### Admission requirements

The European Bachelor's in Transport and Logistics requires:

- either prior completion of a European Qualifications Framework (EQF) level-5 degree (120 ECTS credits);
- or official validation of equivalent experience (at least one year's recognised sector-relevant experience).

PROGRAMME CONTENTS

### 1 - The European Economy, Transportation, and Flow Management

This unit ensures students:

- can organise the flow of goods and persons in the EU and have a good knowledge of the new Incoterms;
- can implement a company's transport policy thanks to their knowledge of commercial, logistic and administrative issues;
- are aware of the specificities of different modes of transport and of trends and developments in international transportation;
- can organise a maximally secure, multimodal shipment, taking into account all relevant criteria;
- can optimise flow management and manage packaging requirements.

### 2 - Transport Law and International Regulations

This unit ensures students:

- can draw up a transportation contract recognising the responsibility of each actor and are familiar with notions of cause and liability clauses;
- are familiar with and can interpret and apply obligatory and advisory texts;
- know how to manage legal disputes;
- are familiar with travel documents and their requirements;
- can avoid the legal pitfalls associated with certain types of transportation;
- have a good knowledge of customs clearance.

### 3 - Logistics Management: Commercial Aspects

This module ensures students:

- understand the importance, requirements and constraints of e-logistics in the context of e-commerce;
- understand reverse logistics procedures in e-commerce;
- can implement a lean manufacturing process in keeping with the interests of businesses;
- can carry out a forecast study and devise an optimal solution in response to given needs;
- can use service sales techniques to complete negotiations and identify client demands;
- can optimise a team's sales force.

### 4 - Professional Experience

A strong point of FEDE European bachelor's degrees is the requirement for students to consolidate their learning and gain a careers head start through hands-on work experience. The aim is to apply the knowledge and skills acquired during the programme and gain professional confidence.

By completing a work placement in their chosen field, students acquire direct knowledge of the sector and all-important experience in their future role. Students also carry out a supervised project. The project requires them to devise and implement a strategy for completing a transportation-logistics assignment.

Students produce a dissertation or activity report and present their findings orally.

### 5 - European Culture and Citizenship

This unit ensures students:

- have a solid knowledge of the workings, institutions, geography, geopolitics and economics of Europe;
- understand the European model and how it differs from other models in terms of history, regulations, law and culture;
- understand Europe in a broader sense (intercultural aspects, human resources, policies, religions, international trade, taxation etc.);
- have the tools necessary to do business in an EU country;
- understand relevant cultural codes and their impact on interpersonal relations;
- can supervise employees and encourage staff mobility in order to raise their international career prospects.

### 6 - Modern European Language

This module ensures students:

- have CEFR level B1 (writing and speaking) in a modern European language;

It results in the awarding of the FEDE Language Certificate; the Certificate is based on the CEFR and is recognised by the IFEF.
